Governor's Proclamation



CDAA-2022-05 - 2021 Drought - California Disaster Assistance Act Funding

CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES

On May 10, 2021, a Governor's Proclamation was issued, declaring a State of Emergency in Colusa County in response to the 2021 Drought. A subsequent Governor's Proclamation was issued on October 19, 2021, to secure funding to assist with drought costs incurred for the temporary emergency supply, delivery, or both, of drinking water or, water for sanitation purposes. This fact sheet contains information regarding the available assistance and California Disaster Assistance Act (CDAA) application information.

Important Disaster Information

The incident period is April 21, 2021 to TBD.

The 2021 Drought incident (CDAA-2022-05) makes available CDAA funding for eligible costs in Colusa County.

Applicants Eligible for Assistance

The following local government entities are eligible for disaster assistance under CDAA:

- Cities
- Counties
- Special Districts
- School Districts
- Community College Districts
- Certain Private Non-profit Organizations

Eligible Private Non-Profit Reimbursement

An eligible private non-profit (PNP) applicant may receive state financial assistance as reimbursement for the performance of essential community services, provided such expenditures meet all the eligibility requirements. PNP activities resulting from self-deployment will not be eligible for reimbursement.

Available Assistance – Public Assistance Program
